Customers can choose the tickets in packs of 200, 300, 400, 600 and 800 tickets to accommodate to the ticket printers. Every pack of ticket is shrink-wrapped to prevent accidental contamination from dust, liquids, moisture and other influences. Moniko promises a speedy production time which takes only 7-10 working days from order. The prompt action ensures less lead time for delivery, and also helps the success of the customers who choose Moniko products in the industry.
