4. A member of the Company (the “**Member**”) may appoint one (or, if he/she/it holds two or more Shares, more than one) proxy of his/her/its own choice. If such an appointment is made, please insert the name and address of the person appointed as proxy in the space provided. **A proxy needs not be a Member but must attend the 2024 AGM in person to represent you.** If more than one proxy is appointed, the original form of proxy may be photocopied for use.

IF YOU WISH TO VOTE AGAINST ANY RESOLUTION, PLEASE TICK (✓) THE BOX MARKED “AGAINST”.** Failure to tick a box will entitle your proxy to cast your vote at his/her discretion or abstain from voting. Your proxy will also be entitled to vote at his/her discretion on any resolution properly put to the 2024 AGM other than those referred to in the Notice. If you wish to vote part of your Shares for and part of your Shares against the relevant resolution in the event that a poll is called, please insert the number of Shares in the relevant box.
6. The form of proxy must be signed by the appointor or his attorney duly authorised in writing or, if such appointor is a corporation, must be either under its common seal or under the hand of an officer, attorney or other person authorised to sign on that behalf.
7. In the case of joint shareholders, the signature of any one shareholder will be sufficient but the names of all the joint shareholders should be stated.
8. Where there are joint holders of any Share, any one of such joint holders may vote at the 2024 AGM, either personally or by proxy, in respect of such Share as if he/she were solely entitled thereto, but if more than one of such joint holders are present at the 2024 AGM personally or by proxy, that one of such joint holders so present whose name stands first in the register of members of the Company in respect of the joint holding shall alone be entitled to vote in respect thereof.
9. In order to be valid, this form of proxy must be completed, signed and deposited at the Company’s Hong Kong branch share registrar and transfer office, Boardroom Share Registrars (HK) Limited at Room 2103B, 21/F., 148 Electric Road, North Point, Hong Kong together with a power of attorney or other authority, if any, under which it is signed (or a notarially certified copy thereof), not later than 48 hours before the time appointed for holding the 2024 AGM or the adjournment thereof. Completion and return of the form of proxy shall not preclude the Members from subsequently attending and voting in person at the 2024 AGM or the adjournment thereof, should they so wish, and in such event, the form of proxy shall be deemed to have been revoked.
10. **Any alteration made to this form of proxy must be initialled by the person who signs it.**
11. The Company reserves its right to treat any form of proxy which has been incorrectly completed in some manner as valid if such incorrectness is considered by the Company, at its absolute discretion, not material.
12. A Member or his/her/its proxy should produce proof of identity when attending the 2024 AGM. If a corporate Member appoints its representative to attend the 2024 AGM, such representative should produce proof of identity and a copy of the resolution of the board of directors or other governing body of that Member appointing such representative to attend the 2024 AGM.

PERSONAL INFORMATION COLLECTION STATEMENT

- (iv) You have the right to request access to and/or correction of your Personal Data in accordance with the provisions of the PDPO.
