**POLL RESULTS OF THE ANNUAL GENERAL MEETING  
HELD ON 28 MAY 2026**

All the Proposed Resolutions as set out in the AGM Notice were duly passed by the Shareholders by way of poll at the 2026 AGM.

The board of directors of Asia Pioneer Entertainment Holdings Limited (the “**Company**”, the “**Directors**” and the “**Board**”, respectively) is pleased to announce that all the proposed ordinary resolutions (the “**Proposed Resolutions**”) as set out in the notice of the annual general meeting of the Company (the “**AGM**”) dated 7 May 2026 (the “**AGM Notice**”) were duly passed by the holders of the Company’s ordinary shares of HK\$0.01 each (the “**Shares**” and the “**Shareholders**”, respectively) by way of poll at the AGM held on Thursday, 28 May 2026 (the “**2026 AGM**”).

As at the date of the 2026 AGM, there were 1,000,000,000 issued Shares entitling the Shareholders to attend and vote for or against the Proposed Resolutions at the 2026 AGM. The Company did not hold any treasury Shares (including any treasury Shares held or deposited with the Central Clearing and Settlement System established and operated by Hong Kong Securities Clearing Company Limited). There were no Shares entitling the Shareholders to attend but abstain from voting in favour of the Proposed Resolutions at the 2026 AGM as set out in Rule 17.47A of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “**GEM**” and the “**GEM Listing Rules**”, respectively).

No Shareholders was required under the GEM Listing Rules to abstain from voting on the Proposed Resolutions at the 2026 AGM. In addition, no Shareholders have stated their intention in the Company’s circular dated 7 May 2026 (the “**Circular**”) to vote against or abstain from voting on any of the Proposed Resolutions at the 2026 AGM.

Boardroom Share Registrars (HK) Limited, the Company’s branch share registrar and transfer office in Hong Kong, was appointed and acted as the scrutineer for the vote-taking at the 2026 AGM.

The executive Directors (“**ED**”), Mr. Huie, Allen Tat Yan, Mr. Ng Man Ho Herman, Mr. Chan Chi Lun and Ms. Maria Fatima Francisco Freire Garcia, as well as the independent non-executive Director (the “**INED**”), Mr. Choi Kwok Wai, attended the 2026 AGM. The INEDs, Mr. Ma Chi Seng and Mr. Ho Kevin King Lun did not attend the 2026 AGM due to their other engagements.
